

HOUSE RULES – EXTRACT

Lurdy Shopping and Office Center is a privately owned building complex which may be used by visitors during opening hours, subject to full compliance with these House Rules.

Children under the age of 14 may only stay on the premises under the supervision of a parent or other responsible adult.

GENERAL RULES

- Visitors must refrain from any activity that is unlawful, disruptive to others, or likely to cause fear, offence, or public outrage.
- In the event of a breach of these House Rules, security staff are entitled to instruct the visitor to leave the premises and, if necessary, to request police intervention.

VISITOR RULES

- Entry is permitted only in clean and appropriate clothing.
- Persons under the influence of alcohol or any mind-altering substance are not allowed to enter.
- Common areas and facilities (restrooms, water fixtures, waste bins) must be used only for their intended purpose.
- In the food court, only food and beverages purchased on site, from the catering units operating there, may be consumed; bringing in and consuming food or drinks from external sources is prohibited.
- Tables and seating in the food court may be used for dining purposes only; private gatherings, meetings, as well as organized or private events are not permitted.

PROHIBITIONS

- Bringing explosives, drugs, pyrotechnic devices, or weapons onto the premises is prohibited (except for on-duty members of the armed or law-enforcement services).
- Organizing gambling activities is only permitted with the prior consent of the owner.
- Smoking is only permitted in designated smoking areas within Lurdy Ház. The smoking ban applies to all tobacco products, electronic cigarettes, and electronic devices simulating smoking.
- The consumption of alcoholic beverages is not permitted, except for drinks purchased in the food court and consumed on the spot.
- The use of scooters and bicycles within the Shopping Center is prohibited; such vehicles may only be brought in if pushed by hand or carried.

VISITORS WITH ANIMALS

- Only well-socialized, clean, healthy, and non-dangerous animals may be brought onto the premises.
- Animals may not be taken into restricted areas or into any shop where animals are expressly prohibited.
- Animals may remain in the food court only if they do not come into contact with food, tableware, or eating surfaces, and do not disturb other guests while dining.
- Dogs must be kept on a short leash at all times; small animals (such as cats, rabbits, rodents, ferrets) may only be brought in a closed pet carrier. For breeds specified by law, wearing a muzzle is mandatory; all dogs are expected to have a microchip, vaccination booklet, and a secure leash and collar or harness.
- Owners are responsible for cleaning up after their animals.
- Lurdy Shopping and Office Center accepts no liability for any injury to, or loss of, animals on the premises.

COMMERCIAL AND PROMOTIONAL ACTIVITIES

- Commercial activities may only be carried out by tenants who have a valid contract with the owner.
- Leaflet distribution, opinion polls, as well as the organization of any public or private event are only permitted with prior authorization.

SANCTIONS

A breach of these rules may result in exclusion from the Shopping Center and, in more serious cases, the initiation of civil, criminal, or other official proceedings.
